Preference for Domestically Manufactured Goods

Your kind attention is requested to Public Finance Circular No. 01/2013 dated 02.01.2013 on "Granting Preference for Domestically Manufactured Goods" for local bidders who participate in the Bids under domestic funds in view of the encouraging domestic entrepreneurs and local manufacturing industries as well.

02. It has been brought to the notice of this department that most of the Procuring Entities (PEs) do not familiar with this policy and the related circular instructions which lead to prevent local bidders from obtaining the price preference for goods offered by them that meet the criteria for application of domestic preference as per the guideline 7.9.6 of the Government Procurement Guidelines-2006(Goods and Works).

03. Therefore, you are kindly requested to inform all the institutions coming under your purview to adhere to the above circular instructions and to incorporate the relevant provisions into the respective bidding documents appropriately so that "Domestic Preference shall be a bid evaluation criteria" and respective bid evaluation is carried out in accordance with the procedure laid down in Section III (4) (Evaluation and Qualification criteria) of Standard Bidding Document for procurement of Goods under National Competitive Bidding (NPA/SBD/Goods/02).

Granting Preference for Locally Manufactured Goods Offered by the Local Bidders who Participate in the Supply Contracts under Domestic Funds

Your kind attention is drawn to the following provisions under 7.9.6 of Government Procurement Guidelines – 2006 on the above subject. In accordance with these provisions, the preference should be given to the goods produced locally in the bid evaluation process as follows.

- 1) Domestically manufactured goods for contracts funded by the World Bank and Asian Development Bank - 15%
- 2) Domestically manufactured goods for the contracts funded by the Government of Sri Lanka - 20%

It is required to grant the margin of preference for the locally manufactured goods with the objective of encouraging local manufacturers in the economic development process. Accordingly, steps should be taken by the public institutions to purchase the goods and services which are manufactured locally by using local raw materials, labour and other factors whenever possible.

2. Domestically manufactured goods are the goods produced by Sri Lankan proprietor/sole ownership or partnerships with 50% Sri Lankans and the products with value addition of 30% or more local raw materials, labour and other factors in ex-works price of local products (except pharmaceuticals) unless otherwise defined in any existing law, regulation, circular or guidelines and conditions in the agreements of donor agencies.
