

Public Finance Circular No. 06/2019

All Secretaries to Ministries Chief Secretaries of Provincial Councils Heads of Departments Heads of Local Government institutions

Heads of Public Corporations, Statutory Bodies, State Banks, Universities and Higher Education Institutions and Chairmen of Government Owned Companies

Provision of General Insurance Cover for the Government Institutions

The circular instructions issued in the Public Finance Circular No. 04/2015 requiring Government Institutions to obtain insurance services only from the state owned insurance companies are hereby amended facilitating a more competitive and level playing field for insurance market in the country.

- 02. Accordingly, General Insurance Covers can be obtained by Government Institutions on competitive basis from Insurance Service Providers registered under the Insurance Regulatory Commission of Sri Lanka (IRCSL) who operate in the market without obtain insurance service from agents/brokers. In obtaining insurance services, the Heads of Organizations should consider among other things, the cost involved, nature of the risk to be covered, and the quality of the service as well as the convenience of obtaining these services to the organizations. Also, insurance service providers should be given adequate time for submission of bids.
- 03. Further, it is appropriate to verify the credibility and the capacity of the insurance company concerned prior to engage with the particular insurance provider in consultation with the Insurance Regulatory Commission of Sri Lanka. Suspension notices issued by the IRCSL will also be published by the Department of Public Finance via its website in addition to the IRCSL website.
- 04. Public Finance Circular No 04/2015 dated 14/07/2015 on the above subject, is hereby repealed and the provisions of this circular will be effective from 19/08/2019.

Public Finance Circular No. 06/2019 (i)

Heads of Public Corporations, Statutory Bodies, State Banks, Universities and Higher Education Institutions and Chairmen of Government Owned Companies

Provision of General Insurance Cover for the Government Institutions

Paragraph 02 of the Public Finance Circular No. 06/2019 dated 15.08.2019 issued on the above matter is hereby revised to be read as follows.

Para - 2

"Accordingly, General Insurance Covers can be obtained by Government Institutions on competitive basis from Insurance Service Providers registered under the Insurance Regulatory Commission of Sri Lanka (IRCSL) through their agents/brokers. In obtaining insurance services, the Heads of Organizations should consider among other things, the cost involved, nature of the risk to be covered, and the quality of the service as well as the convenience of obtaining these services to the organizations. Also, insurance service providers should be given adequate time for submission of bids."

The provisions of the Public Finance Circular No. 06/2019 dated 15.08.2019 other than above shall remain unchanged.
