Guidelines on Corporate Governance and Operational Manual for State Owned Enterprises (SOEs)

This Circular is issued in line with the overarching objective of improving the performance of SOEs while providing them with the required autonomy facilitating the efficient and effective decision making capacities.

2. Guidelines on Corporate Governance (CG)

The "Guidelines on Corporate Governance for State Owned Enterprises" has been drafted along the lines as noted above, so as to make available a framework for SOEs to ensure transparency, fairness, accountability and responsibility in line with the international best practices.

This Guideline embodies provisions relating to the Chairmen and Board of Directors of SOEs in discharging their duties and in structuring their relationships with the stakeholders with an aim to safeguarding the public interest. It is required to establish a robust environment which supports implementation of the good governance practices. This will also ensure efficient and effective strategic decision making in achieving SOEs' objectives in line with the macro economic development priorities.

3. Operational Manual (OM)

This Manual provides operational directions on the conduct of business within the SOE, with the aim of achieving the objectives as given in the relevant Act of Parliament or the Articles of Association. In doing so, this Manual places an importance on inculcating a performance driven culture. This Manual basically sets out the operational directions and guidance and framework whilst the CG sets the strategic level framework as a guidance for Board of Directors in terms of preparing overall high-level planning.

4. Compliance

The enclosed CG and OM are for implementation and compliance by the SOEs as per the applicability provisions stipulated in these publications.

5. Previous Guidelines and Circulars

The hand book on "Public Enterprises Guidelines for Good Governance" issued under the PED/12, and all other circulars issued by the Department of Public Enterprises except those as set out in Annexure 01 are hereby revoked.
