**The requirement of passing the Efficiency Bar Examination relevant to Grade II of Sri Lanka
Administrative Service**

The note under No. IV of Para. 02 of Public Administration Circular No. 10/2015 is revised in the following manner with the inclusion of the facts under No. 4 and 5 with regard to passing the subject of Financial Management and Procurement Procedure for the officers in Grade III of Sri Lanka Administrative Service who have been confirmed in the service before 01.07.2012.

Note:

1. Officers who are confirmed in service within the interim period mentioned in the Service Minute and have not passed the subject of Financial Management in Public Sector which has been prescribed under the second Efficiency Bar Examination conducted as per the provisions of the previous Service Minute up to 31.12.2014, shall pass the subject of Financial Management and Procurement Procedure in Public Sector under the first Efficiency Bar Examination held as per the provisions of the new Service Minute, before promotion to Grade II.

2. Officers who have not been confirmed in the service within the said interim period, shall have been passed the subject of Financial Management and Procurement Procedure in Public Sector under the first Efficiency Bar Examination conducted as per the provisions of the new Service Minute, if they are to be confirmed in the service subsequently.
3. A concessionary period shall be granted for the **officers mentioned in 2. above** to pass the subject of Financial Management and Procurement Procedure in Public Sector at 04 **consequent** sittings from 31.12.2013.
4. Officers who have been confirmed in the service before 01.07.2012 and have not yet passed the subject of Financial Management in Public Sector under the second Efficiency Bar Examination which has been conducted as per the provisions of the previous Service Minute, shall complete the subject of Financial Management and Procurement Procedure in Public Sector under the first Efficiency Bar Examination conducted as per the provisions of the new Service Minute, before promotion to Grade II.
5. **If any officer mentioned in 4. above** loses the opportunity to sit for the subject of Financial Management and Procurement Procedure, as a result of not applying for the same even where such officer is having the opportunity to sit for the above subject on the notification of this decision, a concession shall be granted to such officer for 04 sittings. However, the salary increment shall be differed only at the occasions where the officer is unable to pass the subject within the 04 sittings.
