## Allowances for Field Officers engaged in Extension Activities

A monthly allowance should be paid to encourage the field officers engaged in activities such as agriculture extension, veterinary, irrigation and wildlife, with effect from January 2014 as per the Budget Proposals - 2014 declared by the government, in order to strengthen the extension services at ground level.

02. Accordingly, it is hereby approved the payment of monthly allowance of Rs. 300/- with effect from January 2014 for officers mentioned in the Annex I and Annex II of this circular, who are engaged in extension activities in government institutions under your Ministry/ Provincial Council.
